#### **New Business**

We are currently registered as a business organization with the Secretary of State. The question is, do we want to continue to be more than just a club that holds cookouts or do we want to pursue a greater purpose as a philanthropic organization?

She shared that we would need to do some type of furthering education; specifically, educating people about aviation. Amy suggested updating our library and keeping track of what is in it. 
